The quotes will be publicly opened on March 25, 2024, at the regularly scheduled meeting of the Tipton County Commissioners at 9:00 a.m. in the first-floor meeting room, located at 101 E. Jefferson St., Tipton, Indiana 46072. Quotes received after 12:00 Noon on March 22nd, will not be opened. All quotes must conform to the following conditions:
