### To be eligible for the Infraction Deferral Program, you must:

1. Have had no pointable traffic violations in the last year.

• • •

- 2. Have had no major driving offenses in the last five (5) years. These include OWI and Driving While Suspended.
- 3. Have not had a pointable infraction or local ordinance violation (whether traffic of otherwise) diverted nor a judgment withheld in the last year preceding the date of this offense.
- 4. If you pay the ticket you received, you are not eligible for a traffic deferral.

# \*\*\*\*\*IMPORTANT\*\*\*\*\* IF YOU ARE APPLYING FOR A DEFERRAL AND HAVE NOTIFIED TRAFFIC COORDINATOR AT 765-675-0732 THEN YOU DO NOT NEED TO APPEAR AT YOUR COURT DATE LISTED ON TICKET.
