## Steve Ray – NCIRPC (time 03:15)

Update on planning council; over the last nine years they have secured more than 22million dollars not including ready funds. The impact on each counties includes 35million from ready fund, Tipton County got 4.6million of it over the last 3-4 years, \$30million 21 projects across all 6 counties total of 3 billion dollars in investments.

Asking counties to approve regional strategy.

Commissioners have decided to look over it before making any decisions.

Ready #2 will be announced April 11 500million dollars will be awarded among 15 regions, 75million maximum reward, 250million dollar Lilly endowment grant. After the amount is announced planning for what projects should get that money shall take place.

### **Broad band high speed internet (time 1:21:10)**

So, what is broadband? According to the FCC, the definition of broadband internet is a minimum of 25 Mbps download and 3 Mbps upload speeds. Broadband provides high speed internet access via multiple types of technologies including fiber optics, wireless, cable, DSL, and satellite.
