Katrina Short came forward to ask if this would be a subdivision with many houses. It was explained to Katrina Short that this "subdivision" is simply subdividing the farm ground from the homestead, but that the new owner of the farm ground could place one single-family home, as per the ordinance.

Mike Sottong came forward to ask what would happen to the drainage tiles running through this property. It was explained that this project did receive approval from the Plat Development

Review Committee and that drainage would need to be looked at and approved before any construction project could commence.

Brian Schildmeier came forward to explain that this subdivision is only being done to sell the farm ground and to allow his parents to remain in the home.
