**CALL MEETING TO ORDER:** President, Brad Bagwell called the meeting to order.

**ESTABLISHMENT OF QUORUM:** President Brad Bagwell stated that there was a quorum.

Member Mark Heirbrandt mentioned that the shelving project has been beneficial. Member Mark Heirbrandt stated that there have been so many cornstalks this year that have obstructed drainage. Surveyor Dan Sheets replied that they had a bunch of cornstalks in Clinton County. President Brad Bagwell stated that Howard County had put fencing up around the drain.
