

**Synopsis of:
Tipton County Drainage Board:
Monday July 28th, 2025, at 12:00 pm**

CALL MEETING TO ORDER: President Dennis Henderson called the meeting to order.

SURVEYOR REPORT:

Surveyor Henderson stated that the county highway was working with the surveyor on an issue at 600 N east of US 31. Surveyor Henderson responded that the easement would shrink to about forty feet. Surveyor Henderson informed the board that Phil Beer was reviewing the Doversberg reconstruction. Surveyor Henderson stated that he went to the Clinton County Drainage Board meeting and that Clinton County gave Tipton County permission to move forward with Swamp Creek maintenance establishment. Commissioner Nancy Cline had asked when that would move forward. Surveyor Henderson responded that hopefully by the end of the year it will move forward. Surveyor Henderson informed the board that Steve Miller has most of the work done on the cost share project of the BF West and Nash. Surveyor Henderson stated that Mr. Miller billed the property owners directly.
