

**Synopsis of:
Tipton County Drainage Board:
Monday August 25th, 2025, at 12:00 pm**

MEMBERS PRESENT: Dennis Henderson, Tracey Powell, Nancy Cline, Kristi Hinkle, Jason Henderson

OTHERS PRESENT: Luke Lightfoot and Skip Gunkel.

CALL MEETING TO ORDER: President Dennis Henderson called the meeting to order.

ESTABLISHMENT OF A QUORUM: Quorum established.

MODIFICATIONS TO AGNEDA: None

APPROVAL OF MINUTES: Commissioner Nancy Cline motioned to approve July 28, 2025 meeting minutes as presented. Commissioner Tracey Powell 2nd the motion. Motion was approved.

SURVEYOR REPORT:

Surveyor Henderson stated that the work orders are being issued, and the maintenance work is ongoing.

BOARD BUSINESS/COMMENTS (OLD or NEW):

- A. Request for tile abandoned through personal property: Surveyor Henderson informed the board that Mr. Lightfoot would like to abandon a portion of the Abraham Kirtley tile which affects his overall drainage on his property. Surveyor Henderson stated that Mr. Lightfoot is at the top which would not affect anyone else. Luke Lightfoot was requesting that the Abraham Kirtley tile be abandoned at the upper portion. Mr. Lightfoot described where this portion was on the map. Mr. Lightfoot informed the board that six-inch tiles will be placed on the property which will move that water south into Turkey Creek. Mr. Lightfoot stated that there is too much water going to the county tile in which Lightfoot is trying to relieve some of that pressure. Commissioner Nancy Cline motioned to approve the abandonment of the upper portion of the Abraham Kirtley tile. Commissioner Tracey Powell 2nd the motion. Motion was approved.

CLAIMS: Secretary Hinkle presented the claims in the amount of \$136,150.41. Commissioner Tracey Powell motioned to approve the claims as presented. Commissioner Nancy Cline 2nd the motion. Motion was approved.

PUBLIC COMMENT: Commissioner Nancy Cline had informed the board that the project at 600 N was ongoing. Surveyor Henderson replied that discussion was in progress on the 600 N project.
