# Vacation of Alley in Atlanta, IN – Ordinance BOC 2018-04

**ORDINANCE BOC2018-04** 

# AN ORDINANCE VACATING A PORTION OF AN UNIMPROVED ALLEY IN TIPTON COUNTY, INDIANA

WHEREAS, Indiana code ("IC") Section 36-7-3-12 authorizes property owners in the County, outside an incorporated city or town, who desire to vacate all or part of the public way to file a petition for vacation with the legislative body of the county; and,

WHEREAS, a petition ("Petition") to vacate a public way was filed with the Board of Commissioners of Tipton County, Indiana ("BOC") on the 6th day of August, 2018 by Atlanta Crop Service, Inc. regarding the following public way:

An alley running north and south that lies west of lots 9, 10, 11, 12, 13, 14, and east of lots 15, 16, 17, 18, 19, and 20 in W. C. Kring's Second Addition to the town of Atlanta, Indiana, in Section 36, Township 21 North, Range 4 East, in Cicero Township, Tipton County, Indiana; and,

WHEREAS notice of filing said Petition and setting a public hearing on said Petition for August a.m. was published pursuant to IC 5-3-1-2 in the Tipton County Tribune on Thursday August 9<sup>th</sup>, 2018, and the BOC conducted a public hearing on the 20<sup>th</sup> day of August, 2018, which hearing gave any interested persons the opportunity to appear and object to said Petition; and, WHEREAS, following the public hearing, the BOC finds that the area to be vacated in contiguous to and surrounded on both sides by property owned by Petitioners, and that Petitioners have been using the area for many years with no objections from any person or entity, and that the County has no use for the alley.

NOW THEREFORE, be it ordained by the BOC that the alley described herein above is now vacated and title to the alley is now vested in Atlanta Crop Services, Inc. as provided by Indiana law. A certified copy of this Ordinance shall be furnished to the Auditor of Tipton County, and recorded, in the office of the Recorder, Tipton County, Indiana. This Ordinance shall be in full force and effect from the date of its passage, subject to any further publication and or recording required by Indiana law.

Certification pay shall be in effect Jan 1 to December 15 to qualify for payment on the last pay of the year.

#### \* Dispatchers shall receive on call pay in the maximum amount of \$18.00 per day.

#### \* Pay Range for Salaried Personnel

The salary adopted for each employed person of the County in the 2018 Salary Ordinance is a maximum pay. It will be the decis of the Elected Official and/or Department Head whether they choose to compensate a new employee at the maximum salary or a amount under the maximum salary based on experience and/or education and within the budget appropriation.

#### \* The following positions are full-time salaried positions and will be classified as exempt from overtime:

- \*Elected Official
- \*Director and/or Department Head
- \*Health Sanitarian

As needed and necessary, positions will be evaluated on an individual basis. Additions and/or deletions can be made to the list of exempt positions.

All exempt personnel must meet the Fair Labor Standards salary basis test annually. Additionally: are the employee's job duties directly related to management or general business operations, and does the employee's

primary duty include the exercise of discretion and independent judgement with respect to matters of significance?

#### \* Earned Employee Benefits

Eligible employees will be paid for earned sick days in excess of 30 for the 2017 year in January 2018 (See Handbook) Vacation not taken by the end of the year is forfeited. If an employee is terminated during the year, he/she will be paid for earned vacation days.

\* Plan Commission: The City of Tipton shall reimburse Tipton County for joint services per the interlocal agreement specifications.

ORDINANCE CC2018-06

AN ORDINANCE VACATING
AN UNIMPROVED ALLEY IN TIPTON COUNTY, INDIANA

**WHEREAS**, Indiana code ("IC") Section 36-7-3-12 authorizes property owners in the County, outside an incorporated city or town, who desire to vacate all or part of the public way to file a petition for vacation with the legislative body of the county; and,

**WHEREAS**, the Tipton County, Indiana Board of Commissioners (the "BOC") has enacted a county ordinance requiring the approval of the Tipton County Council (the "Council") in conformity with IC 36-2-2-20 regarding any transfer of real estate with a value of more than One Thousand Dollars (\$1,000.00); and,

**WHEREAS**, a petition ("Petition") to vacate a public way was filed with the BOC on the 6<sup>th</sup> day of August, 2018 by Atlanta Crop Service, Inc. regarding the following public way:

An alley running north and south that lies west of lots 9, 10, 11, 12, 13, 14, and east of lots 15, 16, 17, 18, 19, and 20 in W. C. Kring's Second Addition to the town of Atlanta, Indiana, in Section 36, Township 21 North, Range 4 East, in Cicero Township, Tipton County, Indiana; and,

**WHEREAS** notice of filing said Petition and setting a public hearing on said Petition for August 20, 2018, was published pursuant to IC 5-3-1-2 in the Tipton County Tribune on Thursday August 9<sup>th</sup>, 2018, and the BOC conducted a public hearing on the 20<sup>th</sup> day of August, 2018, at which time no persons or entities objected to the vacation of the foregoing described alley; and,

WHEREAS, following the public hearing, the BOC determined that the area to be vacated is contiguous to and surrounded on the east and west sides by property owned by Petitioners, and that Petitioners have been using the area to be vacated for many years with no objection from any person or entity, and that the County has no use for the alley.

**NOW THEREFORE**, be it ordained by the Council that the alley described herein above is now vacated and legal title to the alley is now vested in Atlanta Crop Services, Inc. as provided by Indiana law. A certified copy of this Ordinance shall be furnished to the Auditor of Tipton County, and recorded, in the office of the Recorder, Tipton County, Indiana. This Ordinance shall be in full force and effect from the date of its passage, subject to any publication and or recording required by Indiana law.

# Resolution CC2018-18 Establishing a Fund for Proceeds of the Sale of Real Estate RESOLUTION NO. CC2018-18

RESOLUTION OF THE COUNTY COUNCIL OF TIPTON COUNTY, INDIANA ESTABLISHING A FUND FOR PROCEEDS OF THE SALE OF REAL ESTATE TO THE TIPTON COUNTY, INDIANA JAIL BUILDING CORPORATION AND MAKING AN APPROPRIATION FROM SUCH FUND

WHEREAS, the Board of Commissioners (the "Board") of the County has executed a lease (the "Lease") with the Tipton County, Indiana Jail Building Corporation (the "Corporation") for the financing of the costs of all or a portion of the acquisition, construction, improvement, and/or equipping of all or any portion of a new county jail facility, located immediately to the west of the Indiana State Highway Garage in Tipton, Indiana, with frontage on the north side of State Road 28 and on the south side of West Jefferson Street (West CR 150 South), and any related improvements, including preliminary expenses and the costs of issuing bonds of the Corporation (collectively, the "Project");

WHEREAS, it is necessary for the Corporation to own the county jail facility and related real estate subject to the Lease (the "Real Estate") for purposes of the construction of the Project and lease of the Real Estate to the County, and the County has approved the transfer of the Real Estate to the Corporation;

WHEREAS, this Council desires to establish a fund of the Corporation for the purpose of the deposit and expenditure of the purchase price received from the Corporation in exchange for the Real Estate (the "Sale Proceeds"); and

WHEREAS, on the date hereof, the Council held a public hearing on a proposed appropriation from such fund.

NOW, THEREFORE, THE COUNTY COUNCIL OF TIPTON COUNTY, INDIANA RESOLVES THE FOLLOWING:

Section 1. There is hereby established a fund of the County designated as the "Tipton County, Indiana Jail Building Corporation 2018 Bond Proceeds Fund" (the "Fund"). Upon receipt from the Corporation, the Sale Proceeds shall be deposited in the Fund and used for the payment of costs of all or any portion of the Project, including any related or incidental expenses and the costs of the issuance of bonds by the Building Corporation to finance the Project.

<u>Section 2.</u> The Sale Proceeds in the amount not to exceed \$300,000 deposited in the Fund are hereby appropriated for the purpose of the payment of costs of all or any portion of the acquisition and construction of the Project. Such appropriation shall be in addition to all appropriations provided for in the existing budget and shall continue in effect until the completion of the described purposes.

Section 3. Any member of the Board of Commissioners or the County Council, the Auditor of the County, and the counsel to the County Council and the County are hereby authorized, empowered and directed, on behalf of the County to take any other action as such individual deems necessary or desirable to effectuate the foregoing resolutions, including the filing of a report of this appropriation with the Indiana Department of Local Government Finance and the execution of an agreement with a financial institution to hold and administer the Fund, and any actions heretofore made or taken be, and hereby are, ratified and approved.

Section 4. This Resolution shall be in full force and effect from and after its adoption by the Council.
