Highway- Bret Morris

Superintendent Morris reported that signage had been installed at the Court Street parking lot. The commissioners asked him to also post signage at the south courthouse parking lot. Superintendent Morris reported that the applications for Community Crossings grant projects were denied by INDOT

due to less money being available and a decision to award to small units that were applying for the first time. Highway will re-submit in 2019. He stated that there would be a preliminary filed check at the truck stop for the roundabout. He also reported that Division Road had been re-striped the full length of the county.

Landfill Farming Bid Opening

One sealed bid, from Grant Dunn, was received by today's deadline. Gerald Shuck opened and read the bid: \$240/acre with 35% flex payment.

Motion by Commissioner Shuck to take the bid under advisement to the next meeting. Second by Commissioner Manier. Motion carries.

Sheriff – Tony Frawley

Sheriff Frawley presented copies of contracts from Combined Communications, Regional Financial Solutions, and Viticas Commissary.

Motion by Commissioner Shuck to authorize Sheriff Frawley to enter into contracts with Combined Communications, Regional Financial Solutions, and Viticas Commissary, pending review by the county attorney. Second by Commissioner Manier. Motion carries.

Sheriff Frawley reported that there was no progress on the purchase of new vehicles. He stated that his goal is to find four 2018 Chevrolet Tahoes this year.

He stated that he has a verbal agreement with a local policeman to take the courthouse security position. He stated that they would be going to the uniform shop. He is looking at the back room of the Commissioners meeting room as a location for the security officer.

He recommended January 1, 2019 as the date to commence enforcement of the no overnight parking ordinance for the Court Street and courthouse south parking lots to allow time to inform the public. Motion by Commissioner Shuck to schedule January 1, 2019, for enforcement of the parking lot policy. Second by Commissioner Manier. Motion carries.

The sheriff also stated that he is dissatisfied with the mental health provider, Community Howard Mental Health.

Tipton County Historical Society – Jill Curnutt-Howerton

The Historical Society is requesting \$8,250 for the celebration of Tipton County's dodransbicentennial. The County was organized January 15, 1844. The kickoff will be January 15, 2019 at 4:30PM at the Historical Society. This event will feature the official return of the restored Commissioner Book "A". The public is welcome and there will be food and drinks provided. There will be a catered dinner at the Kelley Agricultural Museum property on June 28, 2019 and a family event on the Courthouse Square on June 29, 2019, that is open to the public. She reported that the 2016 Bicentennial had cost \$14,000. She also suggested an art contest at the schools to design a county seal. Auditor Townsend informed those in attendance that the County already has a county seal. He went to his office to retrieve the cast iron seal which was most likely manufactured sometime in the nineteenth century.

Motion by Commissioner Shuck to approve \$8,250 to the Tipton County Historical Society and authorize the use of the Courthouse Square for the county dodransbicentennial. Second by Commissioner Manier. Motion carries.

The commissioners tabled discussion of the seal.

Closure of the Courthouse for Thanksgiving and Christmas employee lunches

Ordinance BOC 2018-05 Conflict of Interest

ORDINANCE 2018-05

A ORDINANCE OF THE BOARD OF COMMISSIONERS OF TIPTON COUNTY, INDIANA ESTABLISHING AND ADOPTING A CONFLICT OF INTEREST POLICY

WHEREAS, Tipton County, Indiana, recognizes the importance of eliminating conflicts of interest in the conduct of County business;

WHEREAS, Conflicts of interest are not only against state and federal regulations but are detrimental to the County's good reputation and the public's confidence in County government;

WHEREAS, the Board of Commissioners also recognizes the value of collaboration that occurs at special events and functions such as conferences, dinners, and social outings in which Tipton County officials and employees may be guests of one (1) or more vendors that do business with the County; and

WHEREAS, the Board of Commissioners desires to fulfill both the letter and spirit of federal and state regulations addressing conflicts of interest, and desires to establish a dollar threshold of \$250.00, below which any financial interest or value of any gratuity is not substantial or the gift is an unsolicited item of nominal value.

NOW, THEREFORE, BE IT THEREFORE ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF TIPTON, INDIANA THAT:

- 1. The dollar value of \$250.00, below which any financial interest or value of any gratuity is not substantial and may be accepted per this policy.
- 2. The Board of Commissioners of Tipton County, Indiana, establishes and adopts the Conflict of Interest Policy, which is attached to and made part of this Ordinance.
- 3. This policy shall be effective upon signing by the Board of Commissioners.

Tipton County, Indiana CONFLICT OF INTEREST POLICY

The following paragraphs apply to all public officials and employees of Tipton County, Indiana.

No officers or employees of the county shall neither solicit nor accept gratuities, favors, or anything of monetary value from Consultants, potential Consultants, or parties to subagreements, unless in accordance with this Conflict of Interest Policy. The aforementioned prohibition does not include gratuities, favors, or anything of monetary value under \$250.00. Any financial interest under \$250.00 shall be considered not substantial in accordance with the Code of Federal Regulations.

This policy conforms to the standards set forth in the Code of Federal Regulations and by the Indiana Department of Transportation. A "Consultant" is defined as an individual or firm providing engineering and design related services as a party to a contract with a recipient or subrecipient of federal assistance.
