## **Sheriff – Tony Frawley**

The commissioners agreed to transfer from Outside Professional Services (1000.31100.000.0068) to Courthouse Security Uniform/Equipment (1000.24002.000.0068) to cover a shortfall in that line. At the Sheriff's request, the Commissioners instructed Information Technology Director Steen to set the security cameras to pan the front yard of the Courthouse.

Mr. Steen stated that an extra camera, if needed, would cost approximately \$3,500.

Dr. Carrie Cadwell reviewed the highlights of services provided to Tipton County residents in 2019 by Four County Counseling Center. Last year, they served 243 Tipton County residents. They have partnered with IU Health. They are serving both schools, but not the jail, at this time.

Bill Shepler reported that a walk-through had been done at the jail. The condition has worsened, with infiltration into the basement. In the attic, the rafter tails are rotting and there is white mold. He stated that hardship may be sufficient cause to take the building off the National Register, if necessary to make less expensive repairs in order to save the building.
