The meeting was opened with prayer by Reverend Gary Eberhart of Kemp United Methodist Church and the Pledge of Allegiance.

The agenda was amended to include a report on a Coroner building, West Elwood, and CIP projects.

#### Payroll – Crystal Worthy

Motion by Commissioner Henderson to approve payroll, check date June 14, 2019, in the amount of \$160,407.60. Second by Commissioner Manier. Motion Carries.

#### Claims - Katy Kramer

Motion by Commissioner Henderson to approve miscellaneous claims for docket date June 10, 2019, in the amount of \$478,561.94. Second by Commissioner Manier. Motion carries.

#### Capital Improvement Plan (CIP)- Additional Projects

Project 85, Economic Development Consultants, and Project 86, Fairground Repairs, were added to the Capital Improvement Plan (CIP).

#### **Highway- Bret Morris**

Superintendent Morris reported that the Highway Department was busy changing stone pads to chip and seal.

#### **County Engineer – Phil Beer**

Community Crossing s Matching Grant Projects

Motion by Commissioner Henderson to accept the lowest responsive and responsible bid from Midwest Paving in the amount of \$123,593 for the Michael Lane reconstruction project. Second by Commissioner Manier. Motion carries.

Motion by Commissioner Henderson to accept the lowest responsive and responsible bid from Midwest Paving in the amount of \$392,383.60 for the Mill and Fill projects. Second by Commissioner Manier. Motion carries.

Motion by Commissioner Henderson to accept the lowest responsive and responsible negotiated revised bid from Baumgartner Paving in the amount of \$317,310 for the PUG projects. Second by Commissioner Manier. Motion carries.

Engineer Beer stated that the cost of the bids, with a cost of \$833,286.60, plus the cost of preparing the PUG mix, at \$658,649.56, totaled \$1,491,936.16.

4-H Fairground – Show Arena Pavilion Roof Replacement

Motion by Commissioner Henderson to accept the lowest responsive and responsible bid from Hinkle Construction, in the amount of \$19,500 for 29 gage steel, \$6,939.84 for insulation, and allowing for replacement of rotted wood, for a total cost, not to exceed \$30,000. Second by Commissioner Manier. Motion carries.

Engineer Beer reported that the County Council had approved the \$300,000 appropriation for Bridge 64.

#### **Campbell Crossing Extension**

## Ordinance BOC2019-02 Auditor's Endorsement Fee – First Reading ORDINANCE NUMBER BOC 2019-02

# AN ORDINANCE OF THE TIPTON COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE AUDITOR TO CHARGE A REAL PROPERTY ENDORSEMENT FEE

**WHEREAS**, the Board of Commissioners of Tipton County, Indiana (hereafter "BOC") believe it is necessary to adopt an ordinance to charge a document endorsement fee for the Tipton County Auditor pursuant to Indiana Code Section 36-2-9-18; and,

WHEREAS, the Tipton County Auditor ("Auditor") should be authorized to collect a Ten Dollar (\$10.00) fee ("Endorsement Fee") for each deed or each legal description contained in a deed for which the Auditor is required to endorse; and,

**WHEREAS**, the definition of a "deed" shall include a signed and notarized document, containing a legal description that transfers real property from one owner to another, in contract, bargain, or fee simple; and,

WHEREAS, the imposition of said Endorsement Fee should become effective on July 1, 2019, and should be in addition to any other transfer fee now being charged by the Auditor; and,

**WHEREAS**, said Endorsement Fee shall be deposited in the dedicated fund for maintaining plat books; and,

**WHEREAS**, all other ordinances or parts of ordinances now in effect that are inconsistent with this Ordinance, shall be null and void.

**NOW THEREFORE, BE IT ORDAINED** by the Board of Commissioners of Tipton County, Indiana, that beginning July 1, 2019, the Auditor shall be authorized to charge a Ten Dollar (\$10.00) Endorsement Fee for each deed or each legal description that the Auditor is required to endorse for the transfer real property.
