CALL MEETING TO ORDER: President Dennis Henderson called the meeting to order.

APPROVAL OF MINUTES: Nancy motioned to approve the February 28, 2022 meeting minutes as presented. Tracey 2nd the motion. Motion was approved.

SURVEYORS REPORT:

- A. Rogers & Leavitt Drain: Jason stated that he and George Tebbe discussed the drains and are comfortable moving forward with the hearing. Jason stated that we must send out proper notification and the hearing should be at the May meeting.
- B. Public Private Drainage Presentation: Jason stated that the 2022 subdivision design requirement is at least one acre or more in size. Jason stated that you must have a way to relieve ground water, which is generally done by placing a perimeter tile and out-letting to a drain. Jason talked about the Richman Doversberger-Recobs County Drain, which is located south of Tipton. This tile provides drainage for Cicero Heights, Plumlee, and Davis Addition. Jason presented a plat from 1959 of Cicero Heights Subdivision. Jason stated that the average lot size was 0.8 acres, which is less than the one-acre minimum requirement. Jason stated that the requirement drainage back in 1956 for Cicero Heights was a six-inch tile in the front of the lots and one culvert pipe under the road. Jason stated there was more development added, Davis Addition in 1969 and Plumlee Addition in 1977 and no drainage improvement was done. Jason stated the Richman Doversberger Recobs Watershed has approximately 178 parcels and about 1200 acres. Jason stated if we were to pull the Recobs Leg out of the watershed, it would be approximately 200 acres. Jason states that landowners in Cicero Heights could split the cost to put in five hundred twenty-five feet of six or eight inch sold tile and connect it to the county tile.

CLAIMS: Jason presented the claims in the amount of \$15,725.64. Nancy motioned to approve the claims as presented. Tracey 2nd the motion. The motion was approved.
