The sheriff reported that the sally port floor was finished. He ordered a canopy over the East entrance and the sidewalk connection will be postponed until Spring. He reported that the jail inspection was completed last week, with no issues. The report will be available soon.

Public Comment

Kegan Schmicker of the Tipton Chamber of Commerce requested \$75,000 from the County's EDIT fund, to match a request made to the City, for a countywide marketing and branding project that would include a logo, advertising, letterhead, business cards, social media, billboards, a website, video ads, etc. He also reported that 23 people participated in the Chamber leadership program. The final session is next week. He announced a partnership with IU Health that could offer discounts to Chamber members. He stated that they are working on development of an e-commerce website for Chamber businesses, with one shopping cart for payment. He also stated that they are looking at downtown revitalization, facades, way-finding signage, as well as gateway signage.

Eugene Balenseifer reported that his wife has been attacked on three separate occasions, while jogging, by the same dog. He stated that pit bulls and Rottweilers are running loose in the county. He stated that there are 11 pit bulls in Kempton. He requested a county ordinance that addresses loose dogs. The County Auditor will send a copy of the existing ordinance to the Board of Commissioners and the County Attorney for review. Mr. Balenseifer suggested looking at the ordinance for the Town of Fowler for reference.

Mark Baird stated that the Foundation has drafted a county ordinance for abandoned vehicles. He stated that the big issue is enforcement. He will forward copies to the Board of Commissioners and the County Attorney for review.
