Discussion of use of Federal Grants to fund Raises - Mark Regnier

County Attorney Regnier that Indiana State law prohibits changes to compensation for elected officials after the budget is approved for the ensuing year. He stated that he is no comfortable with extending raises to elected officials. Jim Purvis stated that he and Brad Nichols had attended training at the County Council conference and had learned that the use of payroll for the CARES Act, prohibited use of American Rescue Plan Act (ARPA) for public safety wages or bonuses.

Wastewater Plant Connection – Jim Ankrum, General Manager, Tipton Municipal Utilities Jim Ankrum asked the Council to consider using ARPA grant money to assist in a project to connect the west treatment plant with the main treatment plant, to make use of its larger capacity. He stated that there are operational issues with the west plant.

Dog Shelter - Rick Chandler

Rick Chandler stated that the Kokomo Humane Society is no longer taking out of county animals and that Elwood has been assisting until Tipton can get a facility up and running. A lease was signed July 1, 2021, with the City of Tipton for a facility at 825 W. Jefferson St.. They have raised \$21,000 and are requesting a \$52,000 grant from the Tipton County Foundation. The City of Tipton has \$30,000 in the budget for renovation of the building. He is requesting matching annual donations from the County and City of \$30,000 each and will be asking for donations from the incorporated towns and the general public. Melissa Rhoades stated that the dispatch center had received 132 county and 187 city calls for animal control between July of 2020 and July of 2021.

Assisting, by way of donation, would limit the liability of the County and City as only a funding mechanism. The shelter would have its own liability insurance.

Dennis Henderson stated that three years had been spent on the drainage project in West Elwood and was 90% accomplished. He stated that Mr. McGoff with the Indiana Finance Authority had assured the county that if Tipton County put up \$300,000 out of ARPA grant funds for the sewer project and set aside \$50,000 to cover unpaid customer billing over the next five years, the IFA would cover the rest of the expenses of the project, expected to be approximately \$1.4 million.

Discussion ensued concerning the source of the \$300,000; some indicating a preference to use EDIT funds, instead of ARPA grant funds.
