* Sheriff's deputies are paid longevity as follows:

Jail Matron: Qualifies for longevity schedule

* Sheriff's deputies are eligible to receive certification pay as follows:

Certifications approved by the County Council as of November 1 of each year

Maximum number of certifications per deputy to receive pay: 3

Certification pay shall be in effect Jan 1 to December 15 to qualify for payment on the last pay of the year.

Dispatchers shall receive on call pay in the maximum amount of \$18.00 per day.

* Pay Range for Salaried Personnel

The salary adopted for each employed person of the County in the 2021 Salary Ordinance is a maximum pay. It will be the decisio Official and/or Department Head whether they choose to compensate a new employee at the maximum salary or any amount unde salary based on experience and/or education and within the budget appropriation.

- *Investigator

As needed and necessary, positions will be evaluated on an individual basis. Additions and/or deletions can be made to the list of All exempt personnel must meet the Fair Labor Standards salary basis test annually. Additionally: are the employee's job duties di management or general business operations, and does the employee's

primary duty include the exercise of discretion and independent judgement with respect to matters of significance?

* Earned Employee Benefits

Eligible employees will be paid for earned sick days in excess of 30 for the 2020 year in January 2021 (See Handbook) Vacation not taken by the end of the year is forfeited. If an employee is terminated during the year, he/she will be paid for earned vacation days.

Discussion of American Rescue Plan (ARP) Funds \$2.9 Million

Jim Ashley expressed concern about the use of the \$4.4 Million dollars coming from INDOT from the relinquishment of part of SR28 and SR19, and the future costs.

Brad Nichols stated that we need to look at needs: Roof, Generator, and Old Jail. He proposed a joint meeting of the County Council and Board of Commissioners.

Auditor Townsend suggested that the Board of Commissioners could establish a non-reverting fund to receive the funds, spelling out the authorized use of the funds for road and bridges, as matching funds for grants, and ending when the funds are depleted.

Cumulative Capital Development will be used to upgrade the courthouse elevator and to remodel the men's restroom at the Highway Department.

The Council decided to advertise a joint meeting of the Board of Commissioners and County Council, at 5pm on January 18, 2022, to discuss and prioritize future needs.

Mike Terry asked about the REDI grant. Thirty million dollars has been approved for this region. The sewer project was number 2 on the original list of projects, and all counties had broadband in their proposals. The Indiana Economic Development Commission will decide how the money is distributed, and we should know by January 11, 2022.

Request to Advertise for Additional Appropriations for budgets of Community Corrections and Emergency Preparedness Grants

Motion by Mike Terry to advertise for additional appropriations for Community Corrections and Emergency Preparedness grant budgets. Second by Jan Smith. Motion carries.

Appointments to the Property Tax Assessment Board of Appeals (PTABOA)

Auditor Townsend informed that Council that the Board of Commissioners had voted to reduce the PTABOA board to a three-member board. Assessor Cassons will offer her recommendation for the January 18, 2022 meeting.

Motion by Jim Purvis to approve County Council Minutes for November 11, 2021 as presented. Second by Jan Smith. Motion carries.

Committee Reports

Jim Purvis reported that there is a trail master plan grant available and that they are working on a tier II \$30,000 grant to the City of Tipton, with no match required.

The goodwill committee meeting was cancelled in December. There was no RDC meeting in December, but there will be one in January.

2021 Salary Payouts

A list of salary payouts for 2021 was given to the Council. The Council would like to ask the human resource support to define exempt/non-exempt employees and to develop job descriptions for the personnel committee.

Councilmanic redistricting

Commissioner Henderson informed the Council that the new councilmanic district maps had been redrawn to move 70 people from District 1 to District 2. No current council members have been moved to a different district as a result of the re-districting.

Tablets in the Meeting Room Cabinet.

Brad Nichols asked what was locked in the cabinet in the meeting room. Information Technology Director Bill Steen explained that these are tablets that are for use in conducting electronic meetings, such as Zoom. They have been used by the Commissioners in 2021.
