**MEMBERS PRESENT:** Dennis Henderson, Tracey Powell, Nancy Cline, Jason Henderson, Kristi Hinkle

**CALL MEETING TO ORDER:** President Dennis Henderson called the meeting to order.

**SURVEYORS REPORT:**

- A. **Spraying Update:** Jason stated that there have been one hundred fifty-seven work orders issued so far this year. Jason also stated that thirty-four of those are spraying work orders. Jason said that the office was keeping up the spraying on areas that had been cleared as well as other areas that needed spraying.
- B. **West Elwood:** Jason stated that there has been a change of ownership on a property where there could be a connection to the drain (West Elwood). Jason has been in communication with them and has informed them that the neighbor can connect to the drain.
- C. **Tree removed (Buck Creek):** Jason stated that there was a very large tree removed from the top of the bank of Buck Creek that Helen Tragesser's property is adjacent to. Jason said that there was a claim for reimbursement (to Helen) of the removal of the tree.

**CLAIMS:** Kristi presented the claims in the amount of \$117,232.17. Tracey motioned to approve the claims as presented. Denny 2<sup>nd</sup> the motion. The motion was approved. Jason brought to the board's attention that Unique Lawn Care was done at Suburban Southfield and that Welford will be doing his work next week.

**PUBLIC COMMENT:** George Tebbe stated that on SR 28 there needs to be spraying done. Jason responded that a work order has been issued to Clear Creek for that spray on SR 28. George Tebbe advised that there needs to be a schedule for spraying. Jason replied that there is a spreadsheet for the spraying. Nancy motioned to close public comment. Tracey 2<sup>nd</sup> the motion. Public comment was closed.
