Jim Ashley opened the public hearing for Resolution CC2022-14. There were no comments. Motion by Jim Purvis to close the public hearing. Second by Mike Terry. Motion carried. Motion by Jim Purvis to approve Resolution CC2022-14. Second by Jan Smith. Motion carried.

Abatements – Auditor Gregg A. Townsend

Auditor Townsend presented the 2022 pay 2023 tax abatements, recommending to the Council that they should be considered to be substantially in compliance with the Statements of Benefits presented at the time that the abatements had been granted, particularly in light of the downturn in the economy that the nation is suffering under the Biden administration. He stated that state law allows consideration of circumstances beyond the control of the companies. He noted that most of the abatements are in or nearing their last year. Motion by Jim Purvis to approve Central Indiana Ethanol, LLC and Helena Agri-Enterprises. Second by Jan Smith.

Motion rescinded by Jim Purvis.

Motion by Jim Purvis to approve Central Indiana Ethanol, LLC. Second by Jan Smith. Motion Carried with Kirk Retherford abstaining.

Motion by Jim Purvis to approve all other abatements except the former Hartley Grain, as presented. Second by Kirk Retherford. Motion carried.

Motion by Jim Purvis to approve Helena Agri-Enterprises, as presented. Seconded by Jan Smith. Motion carried, with Kirk Retherford abstaining.

Highway Additional Appropriation

Jim Ashley opened the public hearing for the \$193,500 additional appropriation for the purchase of the salt barn to be reimbursed with SR28 and SR19 relinquishment funds. Brad Nichols stated that the Council had not been consulted and that the salt barn had been ordered without funds to pay for it. Jim Ashley stated that the matter could be set aside for now.

Jim Ashley opened the public hearing for the \$193,500 portion of Resolution CC2022-12. Bob Edinger stated that he was opposed to it.

Motion by Mike Terry to close the public hearing. Second by Jan Smith. Motion carried. Motion by Brad Nichols to approve the \$997,500 appropriation reductions in Highway and the \$997,500 additional appropriations in MVH Restricted. Second by Mike Terry. Motion carried. No action was taken on the \$193,500 additional appropriation.

IMPA Real Estate Purchase Agreement

Brad Nichols stated that the offer is at the original cost of the land with closing costs to the county. Jan Smith stated that IMPA wants to purchase land from the city and county. Jim Purvis stated that he wants to hear the pros and cons to know if it is a good deal. Dick Klein stated that this project is smaller than the project on CR300W. It is 2.5 megawatts and would provide power to the industrial park, not the grid. He explained that they are building up to 250 megawatts to replace coal fired production. No action taken.

Humane Society Feasibility Study – Rick Chandler

Mr. Chandler referenced a presentation made to the Board of Commissioners on June 20, 2022. He stated that the conclusion is that a shelter is needed, immediately, along with two full-time animal control officers. He stated that the City of Tipton has one animal control officer and that she could be used in the county with the county reimbursing the city for her services. He stated that the budget for this year is higher due to increased costs. He provided a financial

statement. He said that the funds requested would be used for operations and to prepare animals for adoption. Surgeries would be paid out of private donations. He suggested that small towns be charged by the animal. He stated that animal costs would be tracked by the animal, including the number of days sheltered. He stated that most grants require 24 month of operational history before consideration. His request is \$30,000 from the county, to be matched by the city. The budget includes one full-time director and a part-time employee.

Committee Reports

Brad Nichols stated that he would like to see a committee to prepare a plan for the ARP money. Jim Ashley reported that there was a meeting yesterday regarding the utilization of the old jail for the Coroner, Health Department, storage, and the Historical Society. He stated that the problem is the \$1.1 Million cost for the Historical Society, as it is a non-governmental facility. He stated that we have no obligation to fund it. He said that we need to prioritize and asked how we include a non-government agency in a public building. He suggested pursuing grant opportunities. Jim Purvis stated that we need to find a way to save the building.

Mike Terry stated that the RDC is meeting monthly and that there is interest by a developer who has purchased land in the southeast quadrant of SR28 and US31.

Jim Purvis stated that there is no trail committee report. He stated that costs of materials have risen and money raised will no longer cover what they had planned. He stated that the Cicero Creek shelving project was moving along well and that it will open the location of the trail by getting that out of the way. He thanked Rick Chandler for his presentation.

Brad Nichols noted that it was Chuck Bell's birthday.

Public Comment

Bob Edinger asked about the sheriff's pension under other business on the agenda. Jim Ashley stated that it had already been addressed.

Motion by Jim Purvis to adjourn the meeting. Second by Jan Smith. Motion carried.
