Budget Form 4-B for all funds must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

Broadband – Harry Diamond

Harry Diamond presented a case for the importance of broadband to Tipton County. He stated that connectivity has become essential for citizens for a variety of purposes. He stated that it is necessary to have connectivity to attract young professionals to the county. Low population density makes it difficult to bring broadband to rural areas, because of the cost involved. Jim Ashley pointed out that the comprehensive plan calls for growth within the incorporated areas. Mike Terry asked if there are maps showing existing coverage. Mr. Diamond stated that such information is proprietary and difficult to obtain. Mr. Diamond asked the County Council to use their influence to pressure the Board of Commissioners to move forward.

Mike Terry reported that the Redevelopment Commission meeting has been cancelled due to lack of business.

The previous amount of \$3,000, approved in October, did not get advertised, and the higher amount reflects a higher expected need for this year.
