The **Physical AgilityTest**. This test will be administered at *9:00a.m.*. You are to meet in the north parking lot of Tri-Central High School 2115 West 500 North, Sharpsville, IN. 46068. Prior to the start of the testing, you will be required to complete a waiver of liability and produce a government issued photo I.D. The physical agility testing standards administered will be the Entry Standards adopted by the Indiana Law Enforcement Academy which can be located at the https://www.in.gov/ilea/physical-fitness-standards/

The **Written Test** will follow for those that have successfully completed the physical Agility Test. Further instructions concerning the written testing will be given to those who successfully completed the physical agility testing.

After a short lunch break the interview will begin at approximately 2:00pm.

## **Minimum requirements for Tipton County Sheriff Candidates:**

- 1. Shall possess a valid Indiana driver's license (or obtain one within 60 days of becoming an Indiana resident) and have no more than eight active points.
- 2. Shall be a US citizen.
- 3. Shall be at least 21 years of age by the date of appointment.
- 4. Shall not have a conviction for operating a vehicle while intoxicated or operating a vehicle with a blood alcohol content of .08% or above or under the influence of drugs.
- 5. Shall have no felony convictions.
- 6. Shall not have been convicted of a crime of domestic violence.
- 7. Shall not have been dishonorably discharged from the military.
- 8. Shall be a high school graduate or possess a GED certificate.
- 9. Shall not have used an illegal drug in the last one (1) year.
- 10. Shall have vision correctable to 20/50
- 11. Shall never have been served with a Protection or No Contact Order.
