WHEREAS, the Plan Commission did certify to the Board of Commissioners on September 16, 2019 the attached amendments with a favorable recommendation,

## ATTACHMENT A

401.02 D. 11. An amendment to a Development Plan may be submitted for approval in accordance with the proceedures for a Development Plan Review as specified in this section.

401.02 D. 11. Development Plan Amendment. Amendments to approved development plans shall be submitted in accordance with the procedures specified above (including application, fees and required materials). The Executive Director shall schedule a development plan review committee meeting to review the amendment application. The committee shall determine if the amendment consists of substantial development/redevelopment/additions in which the approval shall be required of the Plan Commission.

If the committee determines that the amendment is substantial, it will refer the matter for a public hearing before the City of Tipton Plan Commission in accordance with the procedures for a Development Plan Review as specified above in this section.

If the committee determines that the amendment is not substantial, it shall be returned to the Executive Director for administrative approval.
