- Resolution 2018-11 A Fiscal Policy Resolution For Annexing Contiguous Territory To The City Of Tipton, Indiana (Tipton County Jail Super-Voluntary Annexation): Mayor Havens introduced Mike Shaver with Wabash Scientific who done the Fiscal Plan. Mr. Shaver reported this parcel is immediately West of the State Highway Garage. It was a simple straight forward project, no huge difference in municipal services. The extension of utilities to customers inside City limits. Mayor Havens reported the utilities are available to customers inside City limits. He also reported the one liability is the road there are only two residents and the rest are non-taxable entities. A similar situation is 300 South by Fairgrounds, we take that road and it will cost 25-30 K to repair the road. Councilman Ogden made a motion to approve Resolution 2018-11, seconded by Councilman Rippy, with all in favor.
- Ordinance 2018-05 Amendment To Ordinance No. 2018-05 Made After First Reading On June 25, 2018 And After Public Hearing On July 16, 2018 An Ordinance Of The Common Council Of The City Of Tipton, Indiana, Annexing Certain Territory Contiguous To The City Of Tipton, Indiana, Placing The Same Within The Corporate Boundaries Thereof And Making The Same Part Of The City Of Tipton: Councilman Ogden made a motion to approve Ordinance 2018-05 as amended, seconded by Councilman Rippy. Mayor Havens reported the City and County Attorney both agreed we could have the Ordinance amended, we clarification of the quantity of area at 13.66 acres and adding section 7 and section 8. He also reported this is to clean up the ordinance; it doesn't affect the substance of the ordinance. Ordinance 2018-05 As Amended was passed on second and final reading with all in favor.
- Claims: Councilman Rippy made a motion to approve the claims in the amount of \$933,674.13 to include claim numbers 160498-160649, seconded by Councilman Clark, with all in favor.

- Mrs. Vicky Boyd asked if we can disclose the Byal letter. Mayor Havens reported it was regarding a bill on some remediation he got for the property on the NW corner of Dearborn and Main Street.

INDOT and City yet this fall. We need to discuss the design, right of way and the cost issue and get that all aligned. It will then be an informal safe school route. Mayor Havens reported the west side by the Volleyball Courts will be a separate project.

Mayor Havens reported they can build the jail. Commissioner Mullins stated he wanted to offer the Mayor and Council his thanks for the help with this project. He also stated he agrees with Councilman Rippy the City and County are doing very well together.
